

## SELEKTIVNA BIBLIOGRAFIJA RADOVA IZ PODRUČJA SOCIOLOGIJE PROFESIJE

U ovom broju nalazimo tematski blok posvećen profesiji sociolog. Na stjeći da neku tematsku cjelinu upotpunimo što širim informacijama iz toga područja, načinili smo ovu bibliografiju radova iz područja posebne sociološke discipline, sociologije profesije. Ovom bibliografijom želimo također skrenuti pažnju naših sociologa na sociološku disciplinu koja je veoma razvijena u zemljama gdje je i sociologija kao profesija stekla svoje »mjesto pod suncem«.

Bibliografija je tematski grupirana kako bi na taj način naglasila osnovne teme i smjerove istraživanja u sociologiji profesije, područja u kojima se nadopunjuje s drugim posebnim sociologijama i iz kojih se formirala kao posebna sociologija. Prvu grupu čine radovi usko vezani za analizu položaja, statusa, razvoja profesije u društvu. Druga grupa radova su analize pojedinih profesija (kao medicine, prava, inženjera) u društvu. Treća grupa su radovi o profesiji vezani za socijalnu stratifikaciju društva, a četvrta grupu čine radovi o profesijama i organizaciji.

Bibliografija je selektivna u smislu da su prvenstveno odabrane knjige, a zatim članci koji su najčešće citirani.
