That is why I am convinced that you will be particularly intrigued by Professor Soumitra Sharma's key note speech at the 5th International Conference *An Enterprise Odyssey: From Crisis to Prosperity* which was held in Opatija from 26th to 28th June and hosted and organised by the Faculty of Economics and Business, University of Zagreb.

In his inspired speech Professor Sharma shared with the conference participants his philosophical deliberations having argued them provocatively in a text that will leave no one indifferent. The author himself recommended the conference participants to read the text in peace and at their own convenience. I am convinced that you will agree with me that this paper deserves indeed a much wider audience and its undivided attention. Thus, the text is now before you in order to make us all more aware of the impact of the world economic crisis as well as of the crisis within the economic science as well as in the field of tourism. Speaking of history, I would like to proudly point out this year's special highlight for the Faculty of Economics of the University of Zagreb - the 90th anniversary of the Faculty of Economics, making it the oldest and the largest higher education institution in the area of economics and business economics in the Republic of Croatia and the region. It was the formerly mentioned international conference *An Enterprise Odyssey: From Crisis to Prosperity* that marked the commencement of a series of events that will celebrate this important
