Pregled međunarodnih instrumenata

uz hrvatski prijevod, datume potpisivanja i stupanja na snagu za RH

Objavljuje se pregled međunarodnih instrumenata oblikovan u tablicu s podacima koji su relevantni za Republiku Hrvatsku.

Za izvore podataka korištene su relevantne publikacije međunarodnih organizacija, odnosno njihove službene web stranice. Većina instrumenata je pronađena u publikaciji *Ratification of Maritime Conventions (RMC)*. Selektirani su prema važnosti za RH – isključene su neke konvencije koje se odnose samo na određene države u svijetu, a uvrštene su neke konvencije regionalnog značaja koje bi mogle zanimati RH (iz područja zaštite mora i okoliša). U RMC su zadnje objavljene promjene iz listopada 2005., pa je bilo potrebno konzultirati podatke na internetskim stranicama Međunarodne pomorske organizacije (IMO), Međunarodnog pomorskog odbora (CMI), Ujedinjenih naroda (UN) – Europske ekonomske komisije (ECE), Međunarodne organizacije rada (ILO), i sličnih izvora.

Za prijevode su konzultirani službeni izvori: glasilo *Narodne novine – Međunarodni ugovori*; ako postoji stariji prijevod, naveden je izvor *Službeni list SFRJ – Međunarodni ugovori i drugi sporazumi* ; a posebna je pažnja posvećena prijevodima objavljenima u časopisu *Poredbeno pomorsko pravo (PPP)* - izdavač je Jadranski zavod HAZU. Može se uočiti da su mnogi instrumenti stručno prevedeni i objavljeni u časopisu i ranije nego u službenim glasilima, za neke instrumente postoji samo prijevod u časopisu, a za neke je instrumente u časopisu objavljen prijevod Nacrta ili Revizije.

Također se mnogo podataka moglo provjeriti i u online katalogu knjižnice JZ HAZU, jer su upisivane veze među jedinicama, dokumentima u službenim publikacijama, odn. u našem časopisu.

Popis instrumenata u tablici grupiran je tematski (i grafički odvojen) :

- međunarodno javno pravo
- jurisdikcija, arbitraža
- sigurnost plovidbe
- privilegiji, hipoteke, upisnici
- prijevoz stvari i putnika (osim pomorskog prijevoza uključeni su i zračni,

- cestovni i željeznički, te konvencije vezane uz unutrašnju plovidbu)
- radnopravni odnosi
 - zaštita od onečišćenja.

- **prijevod na hrvatski jezik** (u službenim glasilima RH, odn. SFRJ; u časopisu *Poredbeno pomorsko pravo*) ;
- **izvor 2**: podatak o publikaciji u kojoj je objavljen prijevod (kratica naslova, broj / godina) ;
- **dopuna, izmjena (veza)**: polje koje sadrži podatak - oznaku jedinice u tablici koje su srodne ; podatak o tekstualnim proširenjima izvornog teksta konvencija (npr. izmjene, dopune) ; još poneki podatak koje je objašnjen u polju 'Napomena' ;
- **mjesto potpisivanja**: upisani su pronađeni podatci o gradovima u kojima su međunarodni instrumenti donešeni, potpisani (pravopis je usklađen s uputama u Priručniku za pravilno pisanje) ;
- **datum potpisivanja / usvajanja** instrumenta (gggg-mm-dd) ;
- **datum stupanja na snagu** instrumenta (gggg-mm-dd) ;
- slijede podatci koji se odnose na **Republiku Hrvatsku** (osjenčano sivo) :
