Poštovani čitatelji,

Uvjerena kako se autori članaka vesele svojim objavljenim radovima kao što se i ja veselim što su uspješno prošli sve faze strogih recenzentskih postupaka, vjerujem da ste i vi s nestrpljenjem dočekali novi broj *Acta Turistica* kako biste pročitali zanimljive radove iz različitih područja istraživanja i možda dobili ideju za novo istraživanje. Iako po svakom izlasku novog broja *Acta Turistica* u uredništvu časopisa vlada vesela atmosfera, ipak na žalost moram upozoriti na činjenicu da nam se u posljednje vrijeme opetovano događaju stvari koje nas zgražavaju i koje su apsolutno nespojive s radom u akademskoj zajednici.

Kako je broj zaprimljenih radova za recenziju ipak manji od onih u favoriziranim časopisima, tim više zabrinjava nas udio radova koje su autori već objavili pod istim ili sličnim naslovima u drugim časopisima. Uz to, postala je i svojevrsna „moda“ slati radove na recenziju istovremeno u više časopisa, koristiti se komentarima recenzentata, a onda odustajati od objavljivanja rada nakon prihvaćenih recenzentskih postupaka, jer je isti rad u međuvremenu prihvaćen i u nekom drugom, „više rangiranom“ časopisu. I da se ne bi stvorio krivi dojam, radi se ovdje podjednako o domaćim i stranim autorima iz različitih krajeva svijeta. Kako stati na kraj takvom neetičnom ponašanju dijela beskrupuloznih karijerista u znanosti? Praksa *Acta Turistica* je da takvi autori završavaju na „crnoj listi autora“ čiji se radovi više ne zaprimaju na recenzije, a kod svakog utvrđenog slučaja istovremenog recenziranja u više časopisa, o tome se obavještava i uredništvo dotičnog časopisa.

Poznato je da se izuzetno kvalitetni članci objavljuju i u časopisima koji nisu najviše rangirani, ali da se dogodi da i najprestižniji časopisi objave rad koji ne zavređuje prostor u najprestižnijem časopisu. Iako *Acta Turistica* na svjetskoj razini ne ulazi u rang

UVODNIK – EDITORIAL

Dear Readers,

I am convinced that our authors are just as pleased to see their published articles as I am to see that their articles have successfully passed all the stages of the review procedure. I believe that you are eager to read these articles from various research areas and that they will, perhaps, inspire you to start a new research project. Although the publication of each new issue of *Acta Turistica* is usually accompanied by a cheerful atmosphere in the editorial office, this time it is my responsibility to draw your attention to the fact that we have recently faced certain appalling acts that are absolutely incompatible with the standards of conduct in the academic community.

Although *Acta Turistica* receives fewer submitted manuscript than better ranked journals, we are even more concerned with the share of manuscripts submitted which have already been published under the same or similar title in other journals. In addition, it has become ‘fashionable’ to send manuscripts for review to several journals simultaneously and, to use the reviewers’ comments, only to withdraw them from publication once the review process has been completed and the manuscript accepted, due to acceptance of the manuscript in a “higher ranked” journal. To avoid any misinterpretation, I must declare that the authors in question are both local and international. The issue remains: how can we hinder such unethical behaviour on the part of a handful of ruthless ambition-driven careerists? *Acta Turistica’s* practice is to blacklist such authors and refuse to review their manuscripts in the future. Furthermore, every confirmed case of simultaneous reviewing in more than one journal is also reported to the editors of those journals.

Exceptionally high quality articles have been known to appear in journals that may not have the highest ranking, and even the most prestigious journals have published ar-
