SELEKTIVNA BIBLIOGRAFIJA RADOVA NA TEMU »ENERGIJA I DRUŠTVO«

Za ovaj tematski broj sačinili bibliografiju radova koji obrađuju veoma široku tematiku društvenog konteksta i energije. U obilju takovih radova, koji nastaju prvenstveno od prve energetske krize 1973. pa do 1983. godine ograničili smo se samo na knjige budući da bi uključivanje drugih radova (članaka) na tu temu zauzelo preveliki prostor. Radovi su prvenstveno s engleskog a nešto i s njemačkog jezičnog područja.

Osnovna prepostavka kojom smo se rukovodili u sastavljanju bibliografije je da se problemu energije može i mora pristupiti prvenstveno interdisciplinarno. Do nedavno su tehnološka rješenja u domeni energije bila podvrgнутa samo analizi ekonomske opravdanosti. Međutim, danas se uvriježuje kompleksniji pristup, tj. da su tehnološka rješenja uvjetovana određenim društvenim kontekstom ali i da povratno djeluju na društvo. Različite energetske strategije koje danas stoje na raspolaganju kao i različite energetske politike ili odsustvo bilo kakove energetske politike proizvodi i provozditi će višestrukе posljedice. Te posljedice su ekonomske, političke, pravne, psihološke i uvjetuju društvenu strukturu i sistem.

Rukovođeni tako širokim pristupom sačinili smo bibliografiju koja ne pretendira na sveobuhvatnost. Ona je, naravno, selektivna u smislu da su izdvojeni najznačajniji radovi, kao i radovi koji pokrivaju sva područja društvenih znanosti u kojima se istraživanja iz te domene račvaju.

Svrha je ovoj bibliografiji da nas informira o danas već uveliko prihvaćenom kompleksnom pristupu problematici energije u društvu na čemu se kod nas još relativno malo radi, pogotovo sa sociološkog stajališta.
