We conclude the block with *The consolidation of materials in the collections of the National and University library of Bosnia and Herzegovina and The National library of Austria on the cultural and historical heritage of Mehmed-bey Kapetanović Ljubušak*, which is the result of the project realization of the National and University Library of Bosnia and Herzegovina.
