

EDITORIAL

Dear readers,

It is my special honor and pleasure to point out that in this year's issue of the *Journal of the Faculty of Humanities and Social Sciences in Split*, we bring you the announcement of the author Petra Božanić about the fifteenth anniversary of the founding of the Faculty of Humanities and Social Sciences, University of Split. The author, among other things, includes a speech by the Dean from which the faculty's achievements up until now are evident, as well as current projects of the staff of the Faculty of Humanities and Social Sciences in Split, as well as the importance of a number of historical moments regarding the founding of the Faculty, which today has become one of the leading components of the University of Split. The author also informs us about the awards and notices of thanks which were awarded to deserving academics during the celebration of this anniversary. Recipients included teachers, staff, students and other associates of the Faculty of Humanities and Social Sciences in Split.

In the academic section of the *Journal* this year we have ten papers, of which even nine are scientific ones from the branches of philology, art history, and history. Among the other articles in the *Journal*, which are not subject to review, we present a review by Vedran Barbarić of the proceedings of the international scientific conference *Asmosia XI Interdisciplinary Studies on Ancient Stone*, held in Split in May 2015, and which were printed at the end of 2018, as well as Magdalena Nigoević's review of Anita Runjić-Stoil's monograph *Intenzifikacija u jeziku (S primjerima iz hrvatskog i talijanskog jezika)*, which was published in 2020 by the Faculty of Humanities and Social Sciences in Split.

In this issue of our journal, readers can once again learn about the events and activities taking place at the Faculty of Humanities and Social Sciences in Split, as well as at other universities in Croatia. Thus, in addition to the previously mentioned news, in this year's issue of the *Journal* we feature Anita Lunić's report on the conference *XIV. Mediteranski korijeni filozofije* which, despite the unfavorable current circumstances, was held in September 2020 in co-organization with the Department of Philosophy, Faculty of Humanities and Social Sciences in Split and the Croatian Philosophical Society. The editors of the journal are particularly interested in the news by author Snježana Dimzov about the 7th International *PubMet 2020* conference which, due to the pandemic, was the first time fully held online in September 2020, and was organized by the University of Zadar, Department of Information Sciences, the University of Zagreb, Food and Biotechnology Faculty, the Ruđer Bošković Institute and the Croatian Association for Scientific Communication. The conference was held under the auspices of the Ministry of Education, OpenAIRE, the international association of editors of the European Association of Science Editors (EASE), and SPARC Europe. The importance of this conference, besides the number of presenters and the participation of the internationally respected invited lecturers, is that during the conference there were presentations of innovative approaches and discussions were held on current and future challenges in scientific communication and in publishing and evaluating scientific work. Although this conference was primarily intended for the editors of scientific journals, librarians, publishers, and information professionals, this year we could conclude that the interest of academics, teachers, and other experts has improved educational policy, communication, and other research areas regarding current issues, as well as providing news in the field of scientific publishing. As the editor-in-chief of the *Journal of the Faculty of Humanities and Social Sciences in Split*, this fact makes me especially happy and I am anxiously looking forward to the forthcoming 8th International Conference *PubMet 2021*.
