### RESEARCH ON THE PROOF OF DARK NET CRIME WITH MENTAL SUBJECTIVE CONSCIOUSNESS DEFECTS

**Background:** With the development of the Internet, its huge data has developed a huge and unlimited way to convey information for users all over the world. In recent years, with the deepening of people's understanding of the Internet, new crimes in the network are becoming more and more frequent, and its impact is becoming more and more serious. For the new crimes in the Internet, they are divided into surface network, deep network and dark network. The criminal phenomena contained in different levels of cyberspace also have significant differences. In the three-tier cyberspace of table network, deep network and dark network, the practical impact brought by the existence of dark network is extremely obvious. Due to the low-risk characteristics of dark network, a large number of criminal transactions are carried out in dark network. Dark network is the cyberspace generated by the further extension of deep network. Through the continuous generation of special encrypted subsets through deep network, its anonymity and privacy are more obvious. At present, the known dark network space accounts for only 0.1% of the Internet, but it is undeniable that there are a large number of criminal cases in the dark network. Therefore, how to find criminal cases from the dark network and stop the criminal behavior of criminal analysis is of great significance.

Generally speaking, the main reason for criminals' criminal behavior is the lack of spiritual subjective consciousness. Psychology believes that in people's daily life, language, body and other behavior are driven by the initiative of spiritual subjective consciousness. Although it is undeniable that individuals have significant subconsciousness, but the subconsciousness cannot fully dominate individual behavior, so we can know that spiritual subjective consciousness is the main dominant thought of individual behavior. Under the spiritual subjective consciousness, the individual can have a conventional cognition of the surrounding environment and can clarify the positive behavior. At the same time, the spiritual subjective consciousness will drive the individual to carry out the behavior in line with the positive values. Some psychiatrists have proposed that when the individual's spiritual subjective consciousness is defective or lacking, the individual cannot correctly recognize, that is, he cannot produce subjective consciousness for his own behavior. Under the influence of this incomplete consciousness, it is very easy to lead to the individual's behavior and thought contrary to common sense, and serious cases will lead to criminal behavior. How to analyze the mental subjective consciousness of criminals under the criminal behavior in the network environment is an important step to clarify their criminal psychology. At the same time, clarifying the defects of criminals' mental subjective consciousness is also an important method to find the proof of criminals' crime in the Internet. Therefore, the research puts forward the scheme of finding criminal proof by analyzing the defects of criminal's subjective consciousness, so as to improve the efficiency of finding criminal proof in the dark network.

**Objective:** Understand the importance of mental subjective consciousness in the influence of individual behavior, analyze the correlation between mental subjective consciousness defect and criminal behavior, and put forward a criminal behavior proof scheme based on mental subjective consciousness defect.

**Subjects and methods:** Take the criminals with criminal behavior in a city as the research object to investigate, understand the current situation of mental subjective consciousness under criminal behavior, and analyze the influencing factors causing the defects of criminal mental subjective consciousness. Put forward the scheme and strategy of criminal proof in the dark network under the current situation of the defect of criminals' spiritual subjective consciousness.

**Results:** The analysis of the correlation between mental subjective consciousness defects and criminal behavior is shown in Table 1. Table 1 shows that mental subjective consciousness defects include neurasthenia, lack of thinking, backward memory and illogical thinking. By analyzing the effects of neurasthenia, lack of thinking, backward memory and illogical thinking on criminal behavior, it can be found that the above indicators of mental subjective consciousness defects can have a significant impact on criminal behavior, that is, individual mental subjective consciousness defects are important factors for criminals to participate in criminal behavior.

**Conclusions:** The development of the Internet not only improves the convenience of people's life, but also provides a safer online trading environment for criminals to a certain extent. How to prove crime in the dark Internet space is an important task to curb cybercrime. The research analyzes the impact of individual

mental subjective consciousness defects on criminal behavior. The results show that neurasthenia, lack of thinking, backward memory and illogical thinking have a significant impact on criminal behavior. Therefore, in the dark network proof, we can obtain the corresponding information by analyzing the criminal's mental subjective consciousness defects, so as to formulate a perfect dark network crime proof system. The above results show that in order to purify the network environment and curb the occurrence of criminal behavior, we can judge the possibility of criminal behavior by analyzing individual spiritual subjective consciousness, and obtain the certificate of network crime.

## STUDY ON THE IMPROVEMENT OF MIDDLE SCHOOL STUDENTS' MENTAL HEALTH EDUCATION ON SOCIAL ANXIETY

**Background:** Middle school students are a special group. In essence, the psychology of middle school students has many characteristics of youth, but it shows that middle school students are still in the student age. The inferiority complex of middle school students has a serious impact on their communication, which leads to the phenomenon of loneliness and leads to serious loneliness and communication confusion. The jealousy psychology of middle school students is caused by the great differences between students. The family environment and psychological quality of middle school students are different. The students in different family conditions have different ideas about things and poor learning ability. It is still the students who have jealousy psychology. In serious cases, it will damage the health of others, mainly manifested in retaliation for the dissatisfied behavior of others, resulting in retaliation psychology of students. Moreover, after students have a large number of negative psychological obstacles, they will also cause social anxiety to a certain extent. The generation of social communication will further worsen the psychological quality of middle school students in the feedback process. Therefore, how to take reasonable and appropriate mental health education in middle school can not only help students alleviate their psychological emotions, but also improve social communication to a certain extent.
