

Ova knjiga vrlo je važno djelo, posebice za povijest geodezije, jer je to prva geometrija – geodezija napisana na hrvatskom jeziku u Hrvatskoj. Njezino izdavanje je sigurno vrlo važno za upoznavanje s velikom povijesti geodetske struke u Hrvatskoj. Naime, malen broj zemalja u Europi, a još manje i na drugim kontinentima, može se ponositi tako velikom geodetskom prošalošću i tradicijom.

Treba naglasiti da prvoimenovanom uredniku prof. dr. sc. Miljenku Lapaine to nije prvo djelo iz povijesti geodezije. On je već 2002. godine uredio knjigu “*Exercitationes Geodeticæ – Geodetske vježbe*” u kojoj je tiskan faksimil prvog geodetskog udžbenika Martina Szabolovicha na latinskom jeziku, koja je objavljena u Varaždinu 1775. godine. U toj knjizi u izdanju Hrvatskoga geodetskog društva tiskan je i njen prijevod s latinskog na hrvatski jezik. Na taj način suvremeni čitatelj može pratiti početke geodezije u Hrvatskoj, a na osnovi ovih istraživanja može se i tvrditi da je geodezija jedna od najstarijih tehničkih znanosti – struka u Hrvatskoj.

Urednicima knjige prof. dr. sc. Miljenku Lapaine i Dušanu Marjanoviću, dipl. ing. geodezije, kao i nakladnicima knjige predsjedniku Hrvatskoga geodetskog društva Jožefu Delaku, dipl. ing. geodezije i dekanu Geodetskog fakulteta Sveučilišta u Zagrebu prof. dr. sc. Stanislavu Frangešu može se čestitati i zahvaliti im na velikom trudu koji su uložili za izdavanje knjige *ELEMENTA GEOMETRIÆ PRACTICÆ – Zemlyomirje (Uvod u praktičnu geometriju – zemljomjerstvo)*. Ona će poslužiti i koristiti čitavoj geodetskoj znanosti i struci u Hrvatskoj u istraživanju povijesti geodezije i otrgnuti od zaborava prve početke geodezije u Hrvatskoj.
