

IN MEMORIAM

JOSIP KREGAR †

Profesor Josip Kregar umro je 2020. godine te je svojim odlaskom Pravni fakultet i širu zajednicu zakinuo za velikog znanstvenika. Rođen je 1953. godine u Ogulinu. Diplomirao je na Pravnom fakultetu u Zagrebu 1976. godine, a doktorirao 1991. Svoju karijeru nastavio je graditi i dalje, kako radom na znanstvenim radovima, projektima, međunarodnim skupovima i izlaganjima, tako i obrazovanjem na domaćim i stranim sveučilištima. Profesor, doktor znanosti, dekan.

Svojim predavanjima, kako u Hrvatskoj tako i u inozemstvu, dao je velik doprinos široj zajednici. Zapamćen je po uvođenju bolonjske reforme u visokom obrazovanju, zalaganju za kadrovski i prostorni razvoj Fakulteta, promicanju humanih ideala, a sve to samo su neke od njegovih ideja uspješno provedenih u realnost. Autor je i koautor mnogih znanstvenih i stručnih radova, udžbenika, knjiga te političkih eseja. Svojim radom, osim u akademskim krugovima, isticao se i na političkom polju pa je tako, primjerice, od 2012. godine obnašao i dužnost Predsjednika Odbora za pravosuđe Hrvatskoga sabora.

Gledajući popis njegovih radova, vidljivo je i to da je, iako je sociologija bila fokus njegova znanstvenog usavršavanja i doprinos boljitku društva, istraživao i mnoge druge grane prava. Ove prilike prisjećamo se nekih njegovih istraživačkih radova, koji su bitni za razvoj društva i njegovo funkcioniranje, ne samo u Hrvatskoj već i na globalnoj razini. Tako je profesor Kregar kao autor objavio sljedeće radove: “Labour Law Research in Twelve European Countries”, „Uprava i društvo”, “The Institutional Framework of Selfmanagement”, “Kroatien und Mitteleuropa”, “Corruption and Democracy”, “Political Culture in Central and East Europe”, „Nastanak predatorskog kapitalizma i korupcije”, „Javna uprava”, „Sociologija javne uprave”, a kao koautor sljedeće: “Die Verfassung der Republik Kroatien: Politische Rahmenbedingungen und Grundlegende Probleme” u J. Marko,

IN MEMORIAM

JOSIP KREGAR †

Professor Kregar left us too soon in 2020 and with his departure the Faculty of Law and the wider community is left deprived of a great scientist. He was born in 1953 in Ogulin, Croatia. He graduated from the Faculty of Law in Zagreb in 1976, and received his doctorate in 1991. He continued to build his career further, both by working on scientific papers, projects, international meetings and presentations, and by studying at domestic and foreign universities. Professor, doctor of science, dean of our faculty.

With his lectures, both in Croatia and abroad, he made a great contribution to the wider community. He is remembered for introducing the Bologna reform in higher education, advocating for personnel and spatial development of the Faculty, promoting humane ideals, and all these are just some of his ideas successfully implemented into reality. He is the author and co-author of many scientific and professional papers, textbooks, books and political essays. His work, in addition to academic circles, has also distinguished him in the political field, so, for example, from 2012 he held the position of Chairperson of the Judiciary Committee of the Croatian Parliament.

Looking at the list of his works, it is also visible that, although sociology was the focus of his scientific training and contribution to the betterment of society, he also explored many other branches of law. On this occasion, we remember some of his research work, which is important for the development of society and its functioning, not only in Croatia but also on a global level. Thus, Professor Kregar as an author published the following works: *Labour Law Research in Twelve European Countries*, *Management and society*, *The Institutional Framework of Selfmanagement*, *Kroatien und Mitteleuropa*, *Corruption and Democracy*, *Political Culture in Central and East Europe*, *The Rise of Predatory Capitalism and Corruption*, *Public Administration*, *Sociology of Public Administration*, and as a co-

author the following: *Die Verfassung der Republik Kroatien: Politische Rahmenbedingungen und Grundlegende Probleme* in J. Marko, T. Borić (eds); *Slowenien – Kroatien – Serbien: Die neue Verfassungen, Introduction to the National Integrity System Study: Country Report: Croatia 2004, Corruption and Trust, Ethics in Politics and Public Administration*. He also edited *Management of the University and Functional Integration of the University?*.

For his contribution and advocacy for the betterment of the academic and wider community, he will be remembered forever.
