Sastanak je održan ON LINE, u uredi Hrvatskog metalurškog društva (HMD), Zagreb, Berislavićeva 6, sa početkom u 11,00 sati.

Pozvani su na sastanak – sudjelovanje svi članovi sukladno Listi članova na mrežnim stranicama HMD – a, posebice tiskano na poledini (korice)svakog broja časopisa Metalurgija tj.

Sastanak je otvorio glavni i odgovorni urednik časopisa Metalurgija, pozdravio sve članove Uredničkog odbora koji su bili na vezi. Istakao je, u tisku sa daje časopis Metalurgija 64 (2025) 3-4, 245-528, i koji je posljednji koji uređuje, kao glavni i odgovorni urednik od 1985 god., tj. za 41 godinu. Uz to je član HMD – a 65 godina i predsjednik 49 godina, a od 1993 god. predsjednik svih 18 znanstvenih simpozija HMD – a „Materijali i metalurgija“ (33 godina). Ovaj broj časopisa Metalurgija se odnosi na Bibliografiju časopisa 1962. – 2026. god. Daje se cjeloviti prikaz povijesti časopisa tvornice „ Željezare Sisak “ od 1962. god., koju je podigao na svjetsku razinu. Posebice je u Bibliografiji Lista tijela i suradnika, Lista objavljenih radova (3487), Lista autora i suautora (4397). Jednako i svi tiskani sažeci sa 18 simpozija tj. preko 7 000 referata od preko 10 000 autora / suautora. Posebice, daje se i nekoliko odabranih materijala o radu časopisa te galerija slika Uredničkog odbora časopisa.

Hrvatska je do 1990. god. imala proizvodnju cca 3 000 000 tona / god. sa 35 000 zaposlenika. Danas proizvodnja ispod 100 000 t/god. sa cca 150 zaposlenika. Postoji i Metalurški fakultet Sveučilišta u Zagrebu, koji nema studente metalurgije nego druge programe. Preživio je HMD – e i časopis Metalurgija. HMD – e opstoji samo preko finansija koje dobije od časopisa i simpozija.

Uspješnost finansijskog poslovanja HMD – a prepoznato je i u svijetu. Tako je Engleska tvrtka Company Wall Business iz Londona već četvrti put zaredom 2020.,2021.,2022.,2023. je dala Priznanje – Certifikat za uspješno poslovanje HMD - e i uključen je u najpouzdanije organizacije u Hrvatskoj.

Dobili smo i više ponuda iz 10 – ak država o kupovini časopisa uz ponude i iznad 700 000 \$.

Sve sam odbio, ne prodaje se nacionalno blago.

Imam 85 godina, Zub vremena čini svoje, starost i bolest, trebam priznati nestala je potrebna energija. Još prije pet godina, tražio sam zamjenika za obnášanje funkcije u HMD – u i časopisu. Nudio sam čak 10 – ići znanstvenika sa 6 fakulteta, ali nisu voljni preuzeti ove poslove, imaju navodno prevelike druge obveze. Povlačim se poslije 65 godina članstva, 41 godinu kao glavni i odgovorni urednik.

HMD – e u 2025. god. ide u likvidaciju i prestaje biti izdavač časopisa Metalurgija, tako da je već za 2026. god. i sudbina časopisa upitna.

Na kraju svog izlaganja glavni i odgovorni urednik je izrazio veliku zahvalnost svim članovim Uredničkog odbora i za domovine i tuđine za potporu i uspješne zajedničke rezultate.

Na ovaj način prestaje i rad dosadašnjeg Uredničkog odbora i članstva.

Članovi Uredničkog odbora koji se sudjelovali u raspravi izuzetno su se pohvalno izrazili o dosadašnjoj djelatnosti, uspješnosti u tisku godišnje i preko 150 članaka autora / suautora iz 30 – ak država.

Svi su izrazili žal za opravdanim prestankom djelatnosti I.Mamuzić i oni se nadaju možebitnom nastavku tiska časopisa Metalurgija.

The meeting was opened by the Editor-in-chief of Metalurgija Journal, who greeted all the members of the Editorial Board who were in touch. He pointed out that the Journal Metalurgija 64 (2025) 3-4, 245-528, which is the last one he edited, as the Editor-in-chief since 1985, ie. for 41 years. In addition, he has been a member of CMS for 65 years and president for 49 years, and since 1993 President of all 18 scientific symposia of CMS "Materials and Metallurgy" (33 years). This issue of the Metalurgija Journal refers to the Bibliography of the Journal 1962 - 2026. It gives a complete overview of the history of the Journal of the "Željezare Sisak" factory since 1962, which it raised to the world level. Especially in the Bibliography is the List of authorities and collaborators, the List of published works (3487), the List of authors and co-authors (4397). Likewise, all printed summaries from 18 symposia, i.e. over 7 000 papers from over 10 000 authors/ co-authors. In particular, several selected materials about the Journal's work and a gallery of pictures of the Journal's Editorial Board are given.

Until 1990, Croatia was had a production of approx 3 000 000 tons/ year with 35 000 employees. Today, the production is below 100 000 t/year with approximately 150 employees. There is also the Faculty of Metallurgy of the University of Zagreb, which does not have metallurgy students but other programs. CMS also survived the Metalurgija Journal. CMS exists only through the finances it receives from Journal and symposia.

The success of CMS's financial operations is recognized worldwide. Thus, the English Company Company Wall Business from London is already the fourth time in a row in 2020, 2021, 2022, 2023 gave the Recognition - Certificate for the successful operation of CMS and is included in the most reliable organizations in Croatia.

We also received several offers from 10 or more countries to buy Journal with offers above \$ 700 000.

I refused everything, national treasures are not for sale.

I am 85 years old, the ravages of time, old age and illness, I have to admit, the necessary energy has disappeared. Five years ago, I was looking for a deputy to hold a position in CMS and the Journal. I offered as many as 10 scientists from 6 faculties, but they are not willing to take these jobs, they supposedly have too many other obligations. I am retiring after 65 years of membership, 41 years as Editor-in-chief.

CMS in 2025 goes into liquidation and ceases to be the publisher of the Journal Metalurgija, so that already in 2026 and the fate of the Journal is questionable.

At the end of his presentation, the Editor-in-chief expressed his great gratitude to all members of the Editorial Board, both from home and abroad, for their support and successful joint results.

In this way, the work of the current Editorial Board and membership ends.

The members of the Editorial Board who took part in the discussion spoke extremely highly of the previous activity, the success in the press per year and over 150 articles by authors / co-authors from 30 or so countries.

Everyone expressed their regret for the justifiable termination of I. Mamuzić activity and they hope for a possible continuation of the Metalurgija Journal.
