Publication Ethics and Malpractice Statement

The *Journal of Maritime & Transportation Sciences* is a scientific journal with a 54-year old tradition, publishing scientific and professional papers in English language. The contributions are reviewed by at least two prominent national and international reviewers in line with our striving to maintain the journal's high scientific standard. In conformance to standards of ethical behaviour is therefore expected that all parties (publisher, editor, authors and reviewers) the journal will conduct themselves in accordance with the ethics and standards in the process of publishing.

Responsibilities of authors:

By submitting a manuscript to *Journal of Maritime & Transportation Sciences*, the author(s) warrant that the manuscript is their own, original work and that it has neither been published previously nor is currently being considered for publication elsewhere. They also guarantee that the sources of any ideas and/or words in the manuscript that are not their own have been properly attributed through appropriate citations and/or quotes.

Plagiarism in all its forms constitutes unethical publishing behaviour therefore being unacceptable.

Authors should not submit articles describing essentially same research to more than one journal. The corresponding author should ensure that there is a full consensus of all co-authors in approving the final version of the paper and its submission for publication.

Authorship should be limited to those who have made a significant contribution to the conception, design, execution, or interpretation of the reported study. All persons which made significant contributions should be listed as co-authors.

The corresponding author should ensure that all appropriate co-authors and no inappropriate co-authors are included on the paper, and that all co-authors have read/seen the paper, approved the paper final version, and agreed upon its submission for publishing.

Responsibilities of reviewers:

Any manuscripts received for review must be treated as confidential documents. Privileged information or ideas obtained through peer review must be kept confidential and not used for personal advantage. Reviews should be conducted objectively, and observations should be formulated clearly with supporting arguments, so that authors can use them for improving the paper. Any selected referee who feels unqualified to review the research reported in a manuscript or knows that its prompt review will be impossible should notify the editor and excuse himself from the review process.

Reviewers should immediately notify the editor of any similarities between the manuscript under review and another paper either published or under consideration by another journal.

Reviewers should not consider manuscripts in which they have conflicts of interest resulting from competitive, collaborative, or other relationships or connections with any of the authors, companies, or institutions connected to the papers.

Reviewers are specialists in the research areas and they are from different countries (each manuscript is evaluated by two reviewers).

Responsibilities of the editor:

Editor should evaluate manuscripts exclusively on the basis of their academic merit.
Editor should take reasonable responsive measures when ethical complaints have been presented concerning a submitted manuscript or published paper.

Unpublished materials disclosed in a submitted manuscript must not be used in an editor's own research without the express written consent of the author.

The editor must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers, potential reviewers, other editorial advisers, and the publisher, as appropriate.

Editor has the right to make the final decision on whether to accept or reject a manuscript with reference to the significance, originality, and clarity of the manuscript and its relevance to the journal. Editor, in all cases, will inform author(s) about the results from reviewers, when evaluation of manuscript was not successful.

The editor at any time evaluate manuscripts for their intellectual content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, or political philosophy of the authors.
