## **Introduction (style: CRDJ\_title; Oswald Bold 14)**

In introduction the author should summarize previous research and cite most current and relevant literature. Also, gaps in knowledge should be indicated and research questions presented. The introduction should introduce

present research, its purpose and goals. Within the introduction, the hypotheses are stated. (style: CRDJ\_paragraph; Open Sans, 11, space before 6pt)

**Subheading 1 (style: CRDJ\_subheading; Oswald Bold 11, left -0,5cm, space before 20pt, after 12pt)**

Figures should be submitted as separate documents in jpg, jpeg or tiff format. Figures should have minimum resolution of 300 dpi. Every figure should have an individual title. Use italic font and capitalize each word (except and, in, of, with, etc.). For example: Macroeconomic indicators

**References within the text**

Use authors' last names, with the year of publication in parentheses after the last author's name, e.g., "Fettke et al. (2003)"; alternatively, "(Fettke et al., 2003)". If more than one authors is referenced, use first author and "et al.". If more than one article by the same author(s) in the same year is cited, the letters a, b, c, etc. should follow the year. Any direct quotation, regardless of length, must be accompanied by a reference citation that includes a page number.

## **Methodology (style: CRDJ\_title)**

The methodology used in the empirical part of the paper should be appropriate. The authors should use appropriate methods of sampling. Also, instruments, statistical procedures and analysis should be valid and sufficient to examine the data.

## **Results (style: CRDJ\_title)**

Full details of the analyses and results must be provided. Results should be presented clearly.

## **Discussion (style: CRDJ\_title)**

Authors should provide brief discussion. The research question should be answered. Also, limitations of the study should be noted.

## **Conclusion (style: CRDJ\_title)**

Conclusion should be based on answering research questions and/or should include results of hypothesis investigation. Limitations of the study should be noted and further research directions should be proposed.

## **References (style: CRDJ\_title)**

At the end of the paper a reference list in alphabetical order should be supplied. Use APA style for reference. References should not be numbered or bulleted. Use Open Sans, 11pt for reference (style: CRDJ\_paragraph).

### **Books**

Surname, Initials (year). Title of Book (*italic*) (edition). Publisher.

e.g. Michelucci, U. (2019). *Advanced applied deep learning* (1st ed.). Apress.

### **Book chapters**

Surname, Initials (year). Chapter title. In Editor's Surname, Initials (Ed.), Title of Book (*italic*) (Chapter pages). Publisher.

e.g. Slivar, I. (2017). Marketing menadžment u kulturi i turizmu. In Golja, T. (Ed.), *Odabrane teme suvremenog menadžmenta u kulturi i turizmu* (pp. 125-154). Sveučilište Jurja Dobrile u Puli.

### For journals

Surname, Initials (year). Title of article. Journal Name (*italic*), volume and number, pages.

e.g. Can, E. (2019). Fault determination and analysis of complex switching structure at multilevel inverter. *Technical Gazette*, 26(2), 398-404.

If the original version of a non-english article is cited in References, please give the original title and put the English translation in bracket

### For published conference proceedings

Surname, Initials (year of publication). Title of paper. In Surname, Initials (Ed.), Title of published proceeding which may include place and date(s) held (*italic*) (Page numbers). Publisher.

### For unpublished conference proceedings

Surname, Initials (year, date). Title of paper (*italic*) [Conference presentation]. Name of Conference, place of conference. URL if freely available on the internet

### For working papers

### For encyclopedia entries (with no author or editor)

#### **For newspaper articles (non-authored)**

Newspaper (*italic*) (year, date). Article title, pages.

e.g. *Virovitički list* (2014, January 16). Nastavlja se sanacija gradskog odlagališta otpada, 3-4.

#### **For electronic sources**

Surname, Initials (year, date). Title of article (*italic*). Title of website.
