

Instructions to Authors

Authors are kindly requested to read the following instructions when preparing a manuscript for submission to the Journal of Halal Quality and Certification.

The *Journal of Halal Quality and Certification* is an international diamond open access journal published by the Agency for Halal Quality Certification, in collaboration with the Faculty of Technology, University of Tuzla; the Faculty of Islamic Studies, University of Sarajevo (Bosnia and Herzegovina); and the Faculty of Food Technology, Josip Juraj Strossmayer University of Osijek (Croatia).

The journal publishes original scientific articles, short communications, scientific notes, review articles, and professional papers. All manuscripts must be written and submitted in English. All submitted manuscripts undergo peer review.

The distinction between scientific and professional articles lies in the originality of methods, results, and conclusions. Although professional papers may indicate practical applications, they are generally not considered original scientific contributions.

Original scientific papers contain unpublished results of original research. They must include significant and original findings subject to critical evaluation. Experimental data should be presented in a way that allows reproduction and verification of the analyses and conclusions.

Short communications include brief information on research findings that require urgent publication.

Scientific notes include reports on short but completed research or descriptions of original laboratory techniques (methods, equipment, etc.) and should be concise.

Review articles are original, critical, and up-to-date overviews of specific areas in which, preferably, the author is actively engaged. They should include recent references from international publications.

Professional papers present new possibilities

for improvement in the field of halal quality. The emphasis is on the application of known methods and facts, as well as on the dissemination of knowledge in a specific field. Acquired knowledge is applied to the research subject.

Conflict of Interest

Authors must disclose any conflict of interest in the cover letter, within the manuscript, and in the Conflict of Interest Statement. When suggesting reviewers, authors should ensure that colleagues, collaborators, or members of the same institution are not proposed, as such suggestions will not be considered during the review process. Authors may also request the exclusion of specific reviewers, which will be accepted if the reasons are deemed valid.

All authors are required to sign the Authorship Declaration and the Conflict of Interest Statement.

In line with the journal's policy, manuscripts are never sent to reviewers from the same institution. Reviewers must inform the editorial board of any conflicts of interest that would prevent them from providing an objective review, such as recent or ongoing collaboration with the authors, participation in manuscript preparation, direct competition, personal disputes with the authors, financial interests, or political, moral, ideological, or similar issues.

If members of the Editorial or Advisory Board or their close associates submit a manuscript to the journal, they are excluded from the evaluation process. Reviewers are selected in a manner that minimizes the risk of bias during evaluation.

During the review process, editors adhere to the Code of Conduct and Best Practice Guidelines for Journal Editors and the Code of Conduct for Journal Publishers.

If the research involves humans or animals, authors are advised to follow the guidelines of the International Committee of Medical Journal Editors (ICMJE).

For all human subjects, authors must obtain informed consent for participation in research. For subjects under 18 years of age, consent must be provided by a parent or guardian. If the subject is deceased, publication consent must be

obtained from the next of kin. All documentation must be available upon the editor's request and will be treated as confidential.

For all tested subjects, the manuscript must include a statement confirming compliance with relevant guidelines and/or obtained approvals or licenses.

Research involving vertebrates or regulated invertebrates, field studies, and other non-experimental research involving animals must comply with institutional, national, or international guidelines and should be approved by an ethics committee, where applicable. The manuscript must include a statement of compliance and/or appropriate permissions or licenses.

Experimental studies on plants (both cultivated and wild), including plant material collection, must comply with institutional, national, or international guidelines. Field research must be conducted in accordance with local laws, and the manuscript should include a statement of the appropriate permits and/or licenses.

Procedure

All papers are evaluated based on originality and the quality of scientific or professional content. Manuscripts received for consideration are acknowledged by the editorial board. All manuscripts are sent to at least two reviewers. Based on the reviewers' opinions, the editor and the editorial board decide on the acceptance of the manuscript. Submissions may be rejected without review if deemed unsuitable for the journal.

Copyright

The Journal of Halal Quality and Certification applies the Creative Commons Attribution 4.0 (CC BY) license (<https://creativecommons.org/licenses/>) to all published papers, allowing use, distribution, and reproduction in any medium, provided the original work is properly cited.

Authors are fully responsible for the content of their work. The editorial board assumes that by submitting their work, authors have not violated internal regulations or institutional policies and that the manuscript has not been submitted elsewhere. Acceptance of the manuscript

obliges the authors not to publish the same material elsewhere.

Copyright of published works remains with the authors, who grant the Agency for Halal Quality Certification a license to publish the manuscript as the original publisher. Authors also grant third parties the right to freely use the article, provided its integrity is preserved and the original authors, citation details, and publisher are clearly indicated.

Individual users may access, download, copy, display, adapt, and translate manuscripts published in the Journal of Halal Quality and Certification, provided that the intellectual and moral rights and the reputation and integrity of the authors are not compromised.

Users are responsible for ensuring that any reuse complies with the content owner's copyright policies. If content from published manuscripts is copied, downloaded, or otherwise used for research or educational purposes, appropriate bibliographic citation must be provided (authors, journal name, manuscript title, volume, year, page numbers, and link to the published version on the journal's official website: www.congress.halal.ba).

Copyright notes and disclaimers must not be removed. For any unofficial translation of the manuscript, a statement must be included indicating that it is an unofficial translation of the article.

Abstract

The abstract should not exceed 300 words and must include relevant data, methodology, main results, and conclusions. It must not contain abbreviations or references. Following the abstract, authors must provide several keywords.

Keywords

Keywords should relate to the main topic of the paper and should not exceed five words or phrases, separated by commas.

Introduction

The introduction should reference previous research results and explain the purpose of the conducted study.

Materials and Methods

The experimental section should be written clearly and in sufficient detail to allow repetition of the research. Materials and methods should specify instruments, samples, subjects, chemicals, etc., with detailed descriptions provided only if new methods and/or procedures and/or principles are used. For known methods and techniques, an appropriate reference is sufficient.

Results and Discussion

Data shown in tables and figures should not be repeated in the text; only relevant data should be discussed and explained. Combining results and discussion can simplify presentation.

Tables and figures must be self-explanatory without requiring reference to the main text. For publication purposes, they should be submitted in graphic formats (*.xls, *.tif, or *.jpg) and placed at the end of the manuscript.

All illustrations (graphs, schemes, diagrams, images, etc.) are referred to as figures. Figures are cited using the abbreviation "Fig." All figures and tables must be mentioned in the text and numbered in the order of appearance.

Use letters, lines, and symbols that are large and thick enough to be clearly readable even when reduced to published size. In graphs and diagrams, curves should be marked with different point symbols (•, ◊, ○, □, ■, ▲, etc.), not line width or color. Multiple figures can be grouped on one page. Do not place figures in framed boxes. Figure captions and legends should be placed below the figures, while table titles should be placed above the tables. The text in figures and tables must be in the same language as the manuscript.

Whenever possible, formulas and equations should be written on a single line, centered on the page, and numbered with Arabic numerals in parentheses aligned with the right margin. Equations are referred to using the abbreviation "Eq."

SI (International System of Units) must be used. Only symbols (not indices, exponents, or bracketed descriptions) for physical quantities should be italicized. All physical quantities in table columns or rows, table headings with units, and axis labels in graphs must follow

algebraic rules, i.e., physical quantity/unit = numerical value.

It is recommended to write measurement units in the form "kg/m³".

Conclusion

The conclusion should briefly explain the significance of the research results.

References

References should be selective rather than extensive (except in the case of review papers). Literature citations in the text should include the author's last name and year in parentheses, e.g., (Knowles, 2007), or by including the author's name in the sentence followed by the year in parentheses, e.g., "Smith (1963) reported growth on the substrate." For works with more than two authors, only the first author's surname is listed followed by et al. and the year, e.g., (Brown et al., 2015).

In the reference list, which appears at the end of the manuscript, all authors (surname and initials – only the first letter of the first name capitalized) must be listed alphabetically, and works by the same author should be listed chronologically. If an author has several publications from the same year, they are distinguished by letters (a, b, c, d) following the year, both in the text and in the reference list, e.g., (Miller, 2001a). For papers with multiple authors, all authors must be listed in the reference list, not just the first one with "et al."

Italics are used only for words that were originally italicized, such as microorganism names. Journal titles are also written in italics.

For works published online, in addition to basic details (title, author, etc.), the source and date of access must be provided.

Journal abbreviations must comply with the latest edition of the Thomson ISI List of Journal Abbreviations (Thomson Scientific, USA). A period is placed after each abbreviation.
