#### **Guidelines for authors**

The journal publishes research and professional articles from all fields of economics that primarily focus on analyses of the Croatian economy and comparisons with other countries. Contributions relating to economic topics relevant for EU and SEE countries with implications for the Croatian economy are also welcome. The journal also contains a section on book reviews, conference summaries or reports on similar events. The published articles are listed in the AEA (American Economic Association) indexes included in JEL on CD, e-JEL, and EconLit as well as ABI/INFORM, DOAJ, EBSCO, International Bibliography of the Social Sciences (IBSS), SCOPUS and Hrčak – Portal of scientific journals of Croatia.

The journal supports open access to the published articles. No fee is charged for the publication of articles. The authors grant to the publisher exclusive first publication rights (this applies to both print and electronic issue). The editorial board invites contributors to submit their papers to ameryar@eizg.hr.

Submitted articles undergo a double-blind review process. Authors are informed about the final status of their papers within three months from the date of submission. Submitted articles should contain original unpublished work that has not been submitted for publication elsewhere.

Submitted articles should be in Croatian or English, double spaced, approximately 20-30 pages long, accompanied by abstract, keywords (2-5) and JEL classification. The abstract should not exceed 200 words. The abstract, keywords and JEL classification should be in both languages. The first page of the article should contain the article title and the names and affiliations of all authors, as well as their job positions (scientific/teaching positions, if applicable), addresses and e-mail addresses. The first page should be submitted in both languages. Equations, figures and tables should be numbered consecutively with Arabic numerals. Tables and figures should be fully titled. Footnotes to tables and figures (sources and notes) should be placed at the bottom of the table and figure.

Reviews will be taken into consideration only for books which have been published within the last two years. The first page of the book review should contain the name(s) of the book's author(s), the publisher, the place and year of publication, and number of pages. The first page should also contain the name and affiliation, job position (scientific/teaching position, if applicable), address and e-mail address of the author of the review.

The journal uses APA style (<a href="http://www.apastyle.org">http://www.apastyle.org</a>/) to format references in the text and in the literature section.

In the literature section, the author should provide full references for all the works mentioned in the text; also, the reference list should contain only those sources mentioned in the text. They should be listed alphabetically according to the surname of the author, and chronologically if a particular author has more than one work. If several works by the same author were published in the same year, they should be differentiated by letters (a, b, c etc.) following the year of publication. If a work was written by several authors, all authors should be listed instead of using "et al." or "and collaborators". When an article or bibliographic record has a DOI, use the DOI number in the reference list.

# In the submitted research/professional articles and reviews, in-text references should be used as follows:

- The sources should be cited in the text, not in the footnotes. The reference should be in brackets, containing the author's surname and year of publication, e.g.: (Mumford, 1962) or Mumford (1962).
- The page number should be included for quotations or references to books, e.g.: (Mumford, 1962, p. 99).
- If the reference was written by two authors, both should be mentioned, e.g.: (Berger & Luckmann, 1992).
- If the work has three, four or five authors, all the authors' surnames should be listed in parentheses after the first citation. In repeated citations the form "et al." is used, e.g.: (Andlar, Aničić, Pereković, Rechner Dika, & Hrdalo, 2011) / (Andlar et al., 2011).

- If the work was written by six or more authors, the form "et al." is used from the first citation on, e.g.: (Prelog et al., 1979) or Prelog et al. (1979).
- All references in the text should be given as they were given the first time, i.e., forms such as "Ibid.", "Op. cit." and the like, are not used. Authors should use footnotes exclusively for commenting on or expanding on what is referred to in the text.

# The reference list at the end of the article should be written in APA style as in the following examples:

#### Book - one author:

Mumford, L. (1962). The city in history. New York, NY: Harcourt, Brace & World Inc.

#### Book - several authors:

Portes, A., & DeWind, J. (2008). *Rethinking migration: New theoretical and empirical perspectives*. New York, NY: Berghahn Books.

#### Work from an anthology:

Greenberg, M., & Hughes-Evans, D. (1980). Air pollution. In J. Aldrich (Ed.), *Atmosphere, weather and climate* (Vol. 3, pp. 35–75). London: Methuen.

## Article in a journal with a DOI number:
