Submission guide

Croatian Studies Review is a multidisciplinary scholarly journal that accepts original research articles, preliminary communications, state-of-the-art articles, book reviews, and conference reports on topics related to Croatia, Croatians, their language, culture, history, society, etc.

Articles and book reviews for CSR should be submitted as email attachments to CroatianStudiesReview@mq.edu.au.

All submissions should be formatted as follows:

In the email:

Full name of the author/authors

Affiliation

In the Word document: you must adhere to the following:

	Title
Abstract	With keywords (100 – 150 words, in English). Please use Times New Roman size 11.
Heading/Subheadings/Body	Please use Times New Roman size 12 for text body and subheadings, size 18 for heading.
Summary	With keywords 400 – 600 words, in Croatian, French, German, Italian or Spanish. Please use Times New Roman size 11.
References & Bibliography	APA 7th Edition . For more information and examples see below.

Length of articles is limited to 10,000 words, and of book reviews to 2,500 words, which includes bibliography, footnotes and (in the case of articles) the abstract and summary. If the review deals with more than one book, it can be longer than 2,500 words, with an upper limit of 5,000.

From 2022, CSR uses [APA 7th Edition referencing style](https://apastyle.apa.org). Please refer to apastyle.apa.org for more information.

The journal *Croatian Studies Review* is committed to maintaining high standards of ethical conduct and expects all participants in the publication process to comply with ethical research practices.

All articles will go through a double-blind peer review. After the review author(s) may be asked to make changes suggested by referees if deemed necessary by the editors. The CSF reserves the right to reject any articles that do not meet its standards of quality and ethics, or those that are beyond its thematic scope.

CSR uses in-text referencing. This should contain the author's surname(s), the year of the publication, and if necessary, page(s) in the following format:

Referencing with 1 author:

(Moguš, 2009: 31)

Referencing with 2 authors:

(Moguš and Vončina, 1969)

Referencing with more than 2 authors: (Cragie et al., 2016)

Referencing with no author:

(CCH Macquarie Dictionary, 1993)

Referencing with no date:

(UNESCO, n.d.)

Referencing with

organisations/institutions:

(Statistisches Bundesamt, 2017)

Referencing with translations:

(Ylinen, 2007/2008)

Referencing with Chapters:

(Rattan, 2019) Chapter Author.

Referencing list should be alphabetical, and double-spaced.
