Croatian Review of Economic, Business and Social Statistics (CREBSS) is an open access journal published semiannually since 2015, under the [CC BY-NC-ND 4.0](#) license (Attribution–NonCommercial–NoDerivatives). The former publisher of the CREBSS journal was Walter de Gruyter GmbH (Sciendo). Starting from the second issue 2023 (Vol. 9, No. 2) the publisher and the owner is Croatian Statistical Association (CSA). All submitted manuscripts undergo a rigorous and independent double-blinded peer-review process, evaluating articles originality, scientific contribution, clarity, and relevance to the scope of the journal. There is no submission fee or any other article processing charges associated with this journal.

Aims and Scope

The aim of the journal is to provide high quality scientific articles (original research papers, review papers or preliminary communications) which contribute to theoretical and applied statistics. Published articles can be written on English or Croatian. It targets a very wide audience of statisticians, whether they are scientists, professionals, academics or students, influencing modern economy, business and society. It's goal is to be multidisciplinary in nature, promoting the ideas between substantive research areas and exchanging experience and knowledge among statisticians. The scope of the journal is focused, but not limited to the following topics: data mining and machine learning, econometrics, business statistics, biostatistics, social and behavioral statistics, experimental and survey designs, environmental and spatial statistics, teaching statistics and official statistics.

Publication Ethics and Malpractice Statement

Croatian Statistical Association, as the publisher of the CREBSS journal, is committed in ensuring the integrity, transparency and ethical behavior of all parties involved in publication process: authors, editors, reviewers, and the publisher itself. Hrvatska revija ekonomske, poslovne i društvene statistike

Hrvatska revija ekonomske, poslovne i društvene statistike (CREBSS) je časopis otvorenog pristupa, koji se polugodišnje objavljuje od 2015. godine, pod [CC BY-NC-ND 4.0](#) licencijom (Atribucija–Nekomercijalno–NemaDerivata). Nekadašnji izdavač časopisa CREBSS je bio Walter de Gruyter GmbH (Sciendo). Počevši od drugog izdanja u 2023. godini (godište 9, sveščić 2) nakladnik i vlasnik časopisa je Hrvatsko statističko društvo (HSD). Svi dostavljeni rukopisi prolaze strogu i neovisnu dvostruko–slijepu recenziju, ocjenjujući originalnost članaka, znanstveni doprinos, jasnoću i relevantnost djelokruga časopisa. Ne postoji naknada za predaju rukopisa niti bilo koji drugi troškovi obrade članka povezani s ovim časopisom.

Ciljevi i djelokrug

Cilj časopisa je pružiti visokokvalitetne znanstvene članke (izvorne istraživačke radove, pregledne radove ili prethodna priopćenja) koji doprinose teorijskoj i primijenjenoj statistici. Objavljeni članci mogu biti napisani na engleskom ili hrvatskom jeziku. Časopis je usmjeren na vrlo široku publiku statističara, bilo da su oni znanstvenici, stručnjaci, akademici ili studenti, koji utječu na moderno gospodarstvo, poslovanje i društvo u cjelini. Cilj mu je biti multidisciplinarnе prirode, promicati ideje između značajnih istraživačkih područja te razmjenjivati iskustva i znanja među statističarima. Djelokrug časopisa je fokusiran, ali nije ograničen na sljedeće teme: rudarenje podacima i strojno učenje, ekonometrija, poslovna statistika, biostatistika, društvena i bihevioralna statistika, eksperimentalni dizajni i dizajni anketa, statistika okoliša i prostorna statistika, statistika u obrazovanju i službena statistika.

Izdavačka etika i znanstvena čestitost

Otvoreni pristup

Pod Creative Commons licencijom Atribucija–Nekomercijalno–NemaDerivata korisnicima je dopušteno preuzimanje i dijeljenje (čitanje, kopiranje, ispisivanje, distribuiranje ili pretraživanje) punih tekstova te prenošenje doprinosa članaka, pod uvjetom da atribuiraju autora/e za originalno stvaranje, ali ih ne smiju mijenjati ni koristiti u komercijalne svrhe. To je u skladu s BOAI definicijom otvorenog pristupa. Otvoren pristup cjelovitim tekstovima svih radova omogućen je putem sustava [Open Journal System](#), određene [stranice časopisa](#) i portala [Hrčak](#) (mrežna stranica hrvatskih znanstvenih i stručnih časopisa).
